Theories on Recent Unexplained Hyperexpression Trends

Hyperexpression Event:

Hyperexpression can occur in a number of situations involving Quasars. The first of which is during their initial paroxysm, when the Quasar's powers are awakened. Typically, these hyperexpression are in proportional scale to the AEGIS classification of the individual going through paroxysm. Additionally, hyperexpression has been known to occur when the quantum network of a group of nodes is disrupted significantly, e.g. when a member of the team dies while within quantum expression range.

1. The first incident occurred on January 18, 2022, when Pyrus, a Beta class Quasar who worked with the Team Coca-Cola, lost his ability to master fire. Pyrus' powers normally allow him to shape, suppress, and control flames. In this case, however, his powers amplified the host fire source he was using during his performance before a crowd in Indianapolis. His powers flared uncontrollably, sending flames into the crowd and injuring three dozen. The flames continued to grow until Pyrus was knocked unconscious by fast-thinking security operative. Estimates indicate that the situation could have led to nearly two dozen deaths if not for the intervention. Post interrogation of Pyrus indicated that he was not aware of how his powers went to hyperexpression and what may have triggered it. Analytics on his implant indicate that it was operating normally, however, Pyrus has suffered ongoing emotional trauma which has hindered the use of his powers in public.

2. The next event occurred on February 11, 2022, when the Shao-Kahn Brotherhood, a Q-rock band sponsored by Virodar Records, suffered a simultaneous hyperexpression. The group's implants, which were designed to control instrument suites backstage, all went into a hyperexpression at the same time, causing a feedback loop that is estimated exceeded 220 dB, deafening the band and bursting the eardrums of several dozen fans and causing temporary hearing loss in dozens of others. The Shao-Kahn Brotherhood halted their tour and have since returned to the scene, however, no longer as a Q-rock band.

3. On April 14, 2022, an event was reported to AEGIS in an underground fighting circuit. Many of the participants were illegally modified subjects with Bantam or Alpha-level classifications. The implants of seven participants went into hyperexpression, leading to the deaths of fourteen attendees and participants in operation run out of the basement of the Tulum Fight Club. The most profound expression occurred when a drone with the ability to levitate objects violently levitated an observation platform into the adjoining concrete ceiling. AEGIS investigators concluded that that the hyper-expressions were created through feedback caused by illegally modified implants. This

incident was closed, however, the conditional variables for this event would have indicated that they would have had a hyperexpression event well before this time. Additionally, the hyper-expression events all corresponding with different subjects in the same proximity is a statistically impossible probability.

4. On July 14, 2022, the Quasar Tintreach was struck with an unexplained hyperexpression that disrupted the power grid as far as Moderna, Illinois. He suffered a catastrophic power surge that disrupted the regional power grid. Although he suffered no long-term damage from the incident, he chose to remain inactive until he could find a cause for his loss of control.

5. In August 18, 2022, Daedalus sensory networks identified an unusual power surge from Red Glacier during the WDRV attack. His powers, already considered potent, were expressed at a level far outside of his previous abilities. Although he was defeated by Team Daedalus, questions about his actual power levels and how he was able to enhance his abilities has only indicated that he contacted an individual known as Jeannie who had technologies that would allow him to enhance his powers. She contacted him about assisting him and he accepted her help, but his knowledge of her abilities is limited at best.

Theories:

A principal actor with access to Q-tech that modifies and allows modification of the expression of Quasar powers. The ability to empower or disempower Quasars would provide explanations for these anomalies. Conclusion:

Initially, these events seem unrelated, but there is a pattern that coincides with the financial monies moving either to or from these individuals or their related anti-principals, and a series of accounts that have been linked to accounts and sources related to the CoPilot extremist counter-operations assets. The relationships and their specific directions have yet to be fully investigated, but warrants further activity.

Recommendations:

1. Monitor for more hyper-expression events.
2. Increase investigation of financial and intelligence activity of known CoPilot operatives and operations sources.
3. Contact Dr. Stephen Anson regarding a consultation of the type of technologies that might be capable of such feats in reference to Project Intermission.
4. Brief Team Liberty for Rapid Response to Incidents.
