

List of Suspect Charges Influenced by Lt Wm Coswell

1. Emma Ramirez

Activist: Nequality rights advocate

Allegations: Protesting at a Quantek corporate rally and attempting to poison drinks with methanol.

Action: Attempted to impersonate a bartender and replace bottles of vodka with bottles of methanol.

Charges: Criminal Poisoning, Trespassing, Battery, Resisting Arrest

Disposition: Released on Recognizance, Evidence Missing

2. Malik Johnson

Activist: Nequality rights activist

Allegations: Leading violent protests against police brutality and advocating for Nequal rights.

Action: Protesting against the Q-Swat deployment at Sermon Park.

Charges: Assault, Battery, Battery by a Mob, Resisting Arrest

Disposition: Suspect Dismissed for Missing Evidence

3. Elena Rodriguez

Activist: Immigrant rights activist

Allegations: Organized protests against Q-tech testing on immigrants and undocumented citizens.

Action: Vandalizing Chicago Dunlap South Clinic and attacking its staff.

Charges: Five Counts of Assault, Twelve Counts Vandalism, Attempted Arson

Disposition: Remanded for Mental Evaluation, Suspect at Large

4. David Chen

Activist: Workers rights activist

Allegations: Leading strikes and demanding fair wages and working conditions for laborers.

Action: Organized a group of workers to upstage a Ferrotech rally supporting Team Daedalus.

Charges: Inciting a Riot, Trespassing, Resisting Arrest

Disposition: Evidential Testimony Recanted, Evidence Mislabeled

5. Maya Patel

Activist: Nequality rights activist

Allegations: Leading strikes and demanding fair wages and working conditions for laborers.

Action: Organized a group of workers to upstage a Ferrotech rally supporting Team Daedalus.

Charges: Inciting a Riot, Trespassing, Resisting Arrest

Disposition: Evidential Testimony Recanted, Evidence Mislabeled

6. Carl William Fender

Activist: Anti-corruption crusader

Allegations: Breaking into a Ferrotech facility to steal evidence of corruption.

Action: Breaking a lock on a door at the Wisen Street administration offices and stealing the drives from several servers.

Charges: Grand Theft, Hacking, Theft of Classified Corporate Property

Disposition: Evidence Returned, Charges Dismissed

7. Pan Nguyen

Activist: NEQUAL rights advocate

Allegations: Leading labor strikes against lack of protection for workers in hazardous environments.

Action: Organizing violent protests at WDRV broadcast, throwing red die on attendees and staff. Protesting WDRV having another rally after the first one was attacked by Red Glacier.

Charges: Battery, Assault, Vandalism, Inciting a Riot, Resisting Arrest

Disposition: Witnesses Recanted Testimony

8. Almara Alvarez

Activist: NEQUAL Rights Activist

Allegations: Vandalism of several local area signs and cars belonging to Daedalus Foundation staff.

Action: Spray painting offensive phrases on signs, Hitler mustaches, raised right arms, the phrase Q-glizzer was used quite often. Attack packages of flammable liquids to tailpipes and engines of workers of the Daedalus Foundation and recording the cars catching fire, chastising the employees.

Charges: Battery, Assault, Aggravated Assault, Tampering with Evidence

Disposition: Daedalus Foundation Requested Charges Be Dropped
